

FUNDING AND LEVERAGE


We pursue innovative financing mechanisms and strive to leverage our funds for greater impact.


ADVOCACY AND INFLUENCE

OUR GOALS

Save more land

- Accelerate the pace of land conservation
 - Achieve the HarfordNEXT goal of 75,000 acres of private land preserved by 2040
 - Achieve the Maryland the Beautiful goal of 30% of all Harford County land preserved by 2030 and 40% by 2040
- > Pursue proactive, creative, and targeted conservation
 - Where necessary, employ legal tools such as purchase options and financing possibilities such as buy-protectsell arrangements and bridge loans
 - Familiarize industry professionals including lawyers,
 CPAs, and bank trust and estate groups with our work by hosting continuing education events and workshops
 - Access funding for conservation projects tied to water quality and climate resilience goals
- Identify social and community needs that can be addressed through conservation
 - Support opportunities for natural spaces including greenways, pocket parks, and gardens, to foster community and well-being
 - Be sensitive to the need to redress environmental injustice



OUR GOALS

Advocate for conservationoriented government policies and funding

- > Educate policymakers about land conservation
- Press for sufficient and continuing county and state funding for conservation programs
- > Support compatible economic development
- Promote smart growth and appropriate infill and redevelopment
- Serve as a technical resource on complex land use issues such as renewable energy siting, climate impacts, and redevelopment incentives
- Actively participate in Comprehensive Rezoning and Master Planning processes
- Commission and/or author relevant surveys and research
