

**Waiver and Release of Liability for Harford Land Trust's Belle Vue Debut  
10/2/2021 (Rain date 10/3/2021)**

In consideration of being permitted to participate in HLT's Belle Vue Debut (BVD), I, for myself, my personal representatives, assigns, heirs, and next of kin:

1. ACKNOWLEDGE, agree, and represent that I understand the nature of BVD and that I (and those I registered, if applicable) am QUALIFIED, IN GOOD HEALTH, IN PROPER PHYSICAL CONDITION TO PARTICIPATE IN BVD and willingly agree to comply with the stated and customary terms and conditions of participation. I further agree and warrant that if at any time I believe the conditions to be unsafe, I will immediately discontinue further participation in BVD.
  
2. FULLY UNDERSTAND that: a. RUNNING, WALKING, HIKING, AND RELATED OUTDOOR ACTIVITIES ("activities"), INVOLVE RISKS AND DANGERS OF DAMAGE TO PERSONAL PROPERTY AND SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH ("risks"); b. these risks and dangers may be caused by my own actions or inactions, the actions or inactions of others participating in the activities, the conditions in which the activities take place, or THE NEGLIGENCE OF THE RELEASEES NAMED IN THIS REGISTRATION; and c. there may be OTHER RISKS AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my voluntary participation in BVD and activities.
  
3. HEREBY GRANT to the Harford Land Trust the RIGHT TO PHOTOGRAPH ME AND MY REGISTERED PARTY AND USE ANY PUBLICLY SHARED AND/OR EMAILED BVD photos and or other digital reproduction or other reproduction of my/his/her (and my family, if applicable) physical likeness for publication processes, whether electronic, print, digital or electronic publishing via the Internet.
  
4. HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE THE HARFORD LAND TRUST, its agents, administrators, officers, directors, members, volunteers, and employees, other participants in the BVD, any sponsors or advertisers, and HARFORD COUNTY DEPARTMENT OF PARKS & RECREATION, owners and lessors of the premises on which some of the BVD takes place, (considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, INJURIES, DAMAGE TO PROPERTY, OR OTHER DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT I, or anyone on my behalf, makes a claim against any of the releasees, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage or cost which may incur as the result of such claim. BY REGISTERING FOR THE BVD, I CERTIFY THAT I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY AGREEING TO IT AND HAVE AGREED TO IT FREELY AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW. I AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID, THE BALANCE SHALL CONTINUE IN FULL FORCE AND EFFECT.
